Swimming School Policies for Summer Camps

Booking & Enrollment Fees

Enrollment is valid only for the selected session and does not carry over to future sessions. Students joining mid-session must enroll in all remaining classes, with tuition prorated accordingly. **Enrollment is confirmed upon receipt of full tuition and applicable fees.** The \$50 registration fee is non-refundable and non-transferable.

Withdrawals / Cancellations

All cancellation requests must be submitted in writing at the swim facility. A \$50 cancellation fee per session applies. Requests must be received at least **two (2) weeks before** the session start date. No refunds or credits will be issued on or after the session start date. Families enrolled in year-round classes must submit a Cancellation Form by the 25th of the current month to avoid being billed for the following month's regular tuition in addition to Summer Camp tuition.

Missed Classes Policy: Group, Semi-Private, & Private Lessons

Group Sessions: Make-up lessons are not offered. A Free Swim Coupon (non-instructed session) will be issued and may be used during designated open pool hours. Swimmers under age 10 or below Red level must be accompanied in the water by an adult. Coupons are valid for three (3) months from the missed class date.

Semi-Private & Private Sessions: Missed classes may be made up in a Group Summer Camp session, based on availability. All make-ups must be completed within the same enrolled Summer Camp week.

Class Placement & Instructor Policy

Milpitas Star Aquatics will make every effort to accommodate preferred class times; however, placement at a requested time is not guaranteed, including during level adjustments. Students who level up during the week may be required to transfer to a different class time to ensure proper placement. Instructors are subject to change due to staffing needs or unforeseen circumstances. **Refunds will not be issued due to substitute instructors.**

Change Classes

Milpitas Star Aquatics will make every effort to accommodate requested class time changes based on availability; however, changes are not guaranteed. One (1) schedule change per Summer Camp week is permitted. Additional changes within the same week will incur a \$20 processing fee, as adjustments impact class capacity, class assignments, and overall operational planning. **Schedule changes must remain within the originally enrolled week and cannot be transferred.**

Enrollment Agreement & Liability Waiver

1. DEFINITIONS

1. “MSTA” refers to Milpitas Star Aquatics, a California corporation.
2. “Facilities” refers to the aquatic facilities at 1818 Clear Lake Ave, Milpitas, CA 95035.
3. “Services” refers to all programs, activities, and services offered by MSTa at the Facilities, including but not limited to swim lessons, training, public use, and related activities.

2. ACKNOWLEDGEMENT OF RISK: I, on behalf of myself and/or the minor child(ren) listed below:

- Recognize and understand that the use of the Facilities and participation in the Services involve inherent and unforeseeable risks, including serious injury or property damage.
Voluntarily assume full responsibility for all such risks, whether known or unknown.
- Accept full responsibility for any medical expenses incurred as a result of participation.
- Confirm that the Minor(s) are in good physical condition and medically cleared to participate.
- Authorize MSTa staff to secure emergency medical treatment if necessary.

3. WAIVER & RELEASE: In consideration for being permitted to use the Facilities and Services, I, on behalf of myself, the Minor(s), and our respective heirs, representatives, and assigns, hereby:

- Waive, release, and discharge MSTa and its affiliates, directors, officers, employees, contractors, and agents (“Releasees”) from any and all liability, claims, demands, or causes of action arising out of participation in the Services or use of the Facilities.
- Agree not to initiate or join any legal action against the Releasees for injuries, damages, or losses, whether caused by negligence or otherwise.

4. INDEMNIFICATION: I agree to indemnify and hold harmless the Releasees from any claims, liabilities, damages, costs, or judgments (including attorney’s fees) arising directly or indirectly from my and/or the Minor(s)’ participation in the Services or use of the Facilities.

5. PUBLICITY CONSENT: I grant MSTa permission to photograph, record, or otherwise capture images or likenesses of myself and/or the Minor(s) for educational, or promotional purposes. I authorize the use, reproduction, and distribution of such materials in any media, worldwide and in perpetuity, without compensation. This consent is intended to satisfy the requirements of California Civil Code § 3344 and 3344.1, and I waive all claims arising under these or similar statutes.

6. WAIVER UNDER CALIFORNIA CIVIL CODE § 1542:

I acknowledge and expressly waive the protections of California Civil Code § 1542, which provides:

“A general release does not extend to claims which the creditor does not know or suspect to exist in his or her favor at the time of executing the release, which if known by him or her must have materially affected his or her settlement with the debtor.”

This waiver extends to unknown and unsuspected claims.



7. GOVERNING LAW & JURISDICTION: This Agreement shall be governed by the laws of the State of California. I consent to the exclusive jurisdiction and venue of the state courts located in California for resolution of any disputes arising from this Agreement.

8. SEVERABILITY: If any provision of this Agreement is held invalid or unenforceable, the remaining provisions shall remain in full force and effect, and the invalid provision shall be interpreted or modified to the fullest extent possible to remain consistent with the parties' original intent.

ATTORNEYS' FEES: If I initiate, join, or in any way participate in any legal action in violation of this Agreement, I agree to reimburse the Releasees for all reasonable attorneys' fees, court costs, and related expenses incurred in defending or responding to such action.

10. ENTIRE AGREEMENT: This Agreement constitutes the entire and complete understanding between the parties with respect to the subject matter herein and supersedes all prior or contemporaneous discussions, negotiations, agreements, or representations, whether oral or written. No modification, amendment, or waiver of any provision shall be valid or binding unless made in writing and duly executed by both parties.

ACKNOWLEDGEMENT:

I hereby acknowledge that I have carefully read and fully understood this Waiver & Release of Liability Agreement. By signing below, I affirm that I am voluntarily agreeing to its terms and conditions, and that I am aware I am waiving certain legal rights, including the right to pursue legal action or seek compensation for negligence or other claims arising from participation in the Services or use of the Facilities.

PARENT/GUARDIAN ACKNOWLEDGEMENT:

As the parent or legal guardian of the Minor(s), I represent that I have full legal authority to sign this Agreement on their behalf. I consent to their participation in the Services and use of the Facilities and agree to all terms and conditions herein.
